

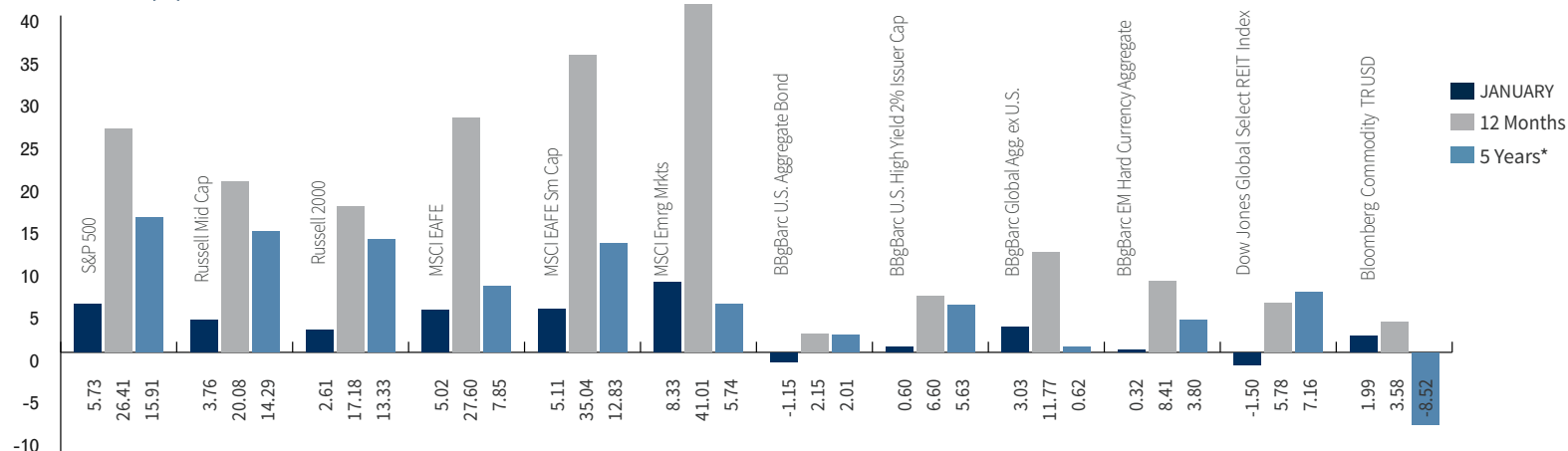
# MONTHLY CAPITAL MARKETS REVIEW

News from Asset Management Services Institutional Research

## JANUARY HIGHLIGHTS

- Investors holding broadly diversified portfolios across asset classes and regions should have achieved positive results in January, as equity markets continued their uptrend mostly unabated. Emerging markets equity gained an enviable 8.33% in January, according to the MSCI EM index.
- Domestically, U.S. large cap stocks represented by the S&P 500 index returned 5.73%. U.S. large-cap equity performance was led by consumer discretionary and tech stocks, which returned 9.34% and 7.63%, respectively. At the other end of the spectrum were utilities, the only sector with a negative return last month of 3.07%. The possibility of multiple interest rate hikes by the Fed in 2018 has undermined utilities companies' outlook given their interest rate sensitivity.
- Among equity styles, growth stocks continue to outperform core and value, led by U.S. large cap growth equity, which gained 7.08% in January.
- While international fixed income had a blockbuster month in January and returned 3.03% according to the BBgBarc Gbl Agg Ex USD index, U.S. bonds struggled, as the 10-year treasury yield inched higher from 2.41% to 2.71%. As such, U.S. core fixed income lost 1.15%, as per the BBgBarc US Agg Bond index.
- Less interest rate sensitive bonds, such as high yield represented by the BBgBarc US HY 2% Issuer Cap index, held their own and gained 0.60% in January. Commodities were also positive for the month, returning 1.99% as per the Bloomberg Commodity index. Two widely-followed commodities, gold and crude oil, gained 4.19% and 7.13%, respectively.

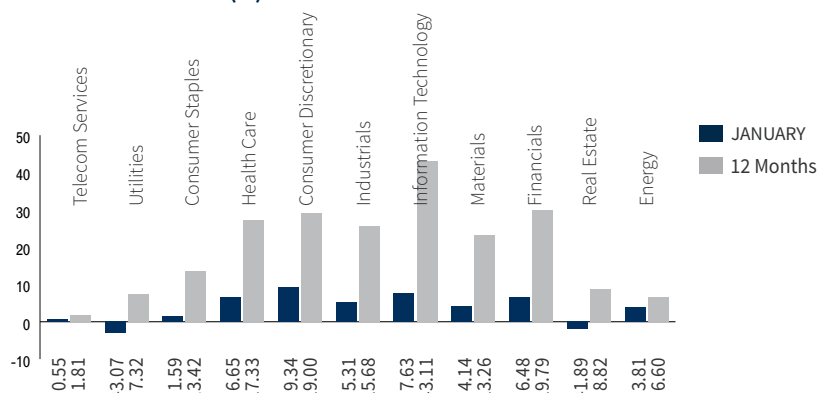

**INDEX DESCRIPTIONS:**

**BBgBarc EM Hard Currency Aggregate:** The Bloomberg Barclays EM Hard Currency Aggregate index covers countries and sectors of the emerging markets fixed income investment universe, which includes USD-denominated emerging markets corporate and government-related debt.

**BBgBarc U.S. Aggregate Bond Index:** Measures changes in the fixed rate debt issues rated investment grade or higher by Moody's Investors Service, Standard and Poor's, or Fitch Investor's Service, in that order. The Aggregate Index is comprised of the Government/Corporate, the Mortgage-Backed Securities, and the Asset-Backed Securities indices.

**BBgBarc U.S. Municipal Bond Index:** The U.S. Municipal Index covers the USD-denominated long-term tax exempt bond market. The index has four main sectors: state and local general obligation bonds, revenue bonds, insured bonds, and prerefunded bonds local general obligation bonds, revenue bonds, insured bonds, and prerefunded bonds.

**BBgBarc Global Aggregate ex U.S.:** Measures changes in global investment-grade, fixed-rate debt markets. It combines non-U.S. dollar-denominated versions of the Pan-European Index and the Japanese, Canadian, Australian and New Zealand components of the Global Treasury Index.

**BBgBarc U.S. High Yield 2% Issuer Cap index :** The Bloomberg Barclays US Corporate High Yield 2% Issuer Capped

Bond Index is an issuer-constrained version of the flagship US Corporate High Yield Index, which measures the USD-denominated, high yield, fixed-rate corporate bond market. The index follows the same rules as the uncapped version, but limits the exposure of each issuer to 2% of the total market value and redistributes any excess market value index wide on a pro rata basis.

**MSCI EAFE (Europe, Australasia, Far East):** A free float-adjusted market capitalization index that is designed to measure developed market equity performance, excluding the United States & Canada. The EAFE consists of the country indices of 21 developed nations.

**The Dow Jones Global Select REIT Index:** intends to measure the performance of publicly traded real estate securities. The indices are designed to serve as proxies for direct real estate investment, in part by excluding companies whose performance may be driven by factors other than the value of real estate. This index represents equity real estate investment trusts (REITs) and real estate operating companies (REOCs) traded globally.

**MSCI EAFE Small Cap:** The MSCI Developed Markets Small Cap Indices offer an exhaustive representation of this size segment by targeting companies that are in the Investable Market Index but not in the Standard Index in a particular developed market. The indices include Value and Growth style indices and industry indices based on the Global Industry Classification Standard (GICS).

**MSCI EAFE Value:** Represents approximately 50% of the free float-adjusted market capitalization of the MSCI EAFE index, and consists of those securities classified by MSCI as most representing the value style.

**MSCI EAFE Growth:** Represents approximately 50% of the free float-adjusted market capitalization of the MSCI EAFE index, and consists of those securities classified by MSCI as most representing the growth style.

**MSCI Emerging Markets:** A free float-adjusted market capitalization index that is designed to measure equity market performance of emerging markets. As of June 2, 2014, the index consists of the following 23 emerging market country indices: Brazil, Chile, China, Colombia, Czech Republic, Egypt, Greece, Hungary, India, Indonesia, Korea, Malaysia, Mexico, Peru, Philippines, Poland, Qatar, Russia, South Africa, Taiwan, Thailand, Turkey, and the United Arab Emirates.

**MSCI Local Currency:** A special currency perspective that approximates the return of an index as if there were no currency valuation changes from one day to the next.

**MSCI EAFE U.S. Dollar:** An unmanaged capitalization-weighted index of companies representing the stock markets of Europe, Australasia and the Far East.

**Russell 1000:** Measures the performance of the 1,000 largest companies in the Russell 3000 Index, which represents approximately 90% of the investable U.S. equity market.

**Russell 1000 Value Index:** Measures the performance of those Russell 1000 companies with higher price-to-book ratios and lower forecasted growth values.

**Russell 1000 Growth Index:** Measures the performance of those Russell 1000 companies with higher price-to-book ratios and higher forecasted growth values.

**Russell Mid-cap:** Measures the performance of the 800 smallest companies of the Russell 1000 Index, which represent approximately 30% of the total market capitalization of the Russell 1000 Index.

**Russell Mid-cap Value Index:** Measures the performance of those Russell Mid-cap companies with lower price-to-book ratios and lower forecasted growth values.

**Russell Mid-cap Growth Index:** Measures the performance of those Russell Mid-cap companies with higher price-to-book ratios and higher forecasted growth values.

**Russell 2000:** Measures the performance of the 2,000 smallest companies in the Russell 3000 Index, which represent approximately 8% of the total market capitalization of the Russell 3000 Index.

**Russell 2000 Value Index:** Measures the performance of those Russell 2000 companies with lower price-to-book ratios and lower forecasted growth values.

**Russell 2000 Growth Index:** Measures the performance of those Russell 2000 companies with higher price-to-book ratios and higher forecasted growth values.

**Russell 3000:** Representing approximately 98% of the investable U.S. equity market, the Russell 3000 index measures the performance of the largest 3,000 U.S. companies

**Standard & Poor's 500 (S&P 500):** Measures changes in stock market conditions based on the average performance of 500 widely held common stocks. Represents approximately 68% of the investable U.S. equity market.

**Bloomberg Commodities Index:** Formerly known as Dow Jones UBS Commodity Index (DJUBS). The Bloomberg Commodity Index is calculated on an excess return basis and composed of futures contracts on 22 physical commodities. It reflects the return of underlying commodity futures price movements.
